




Figure 1 Total FTE employment in main and second jobs in the second Quarters 2007 to 2013



Quarterly National Household Survey Employment in Full-Time Equivalents Quarter 2 2007-2013

This report presents, for the first time, a measure of Full-Time Equivalent (FTE) employment using data from the Quarterly National Household Survey (QNHS). This FTE measure complements the existing published data from the QNHS and gives an additional insight into Ireland's labour market.

The existing QNHS report gives a figure for the number of *persons* in employment and disaggregates this into the number of persons in full-time employment and the number in part-time employment. These new FTE data show the number of full-time equivalent units of employment being worked by these persons. For future quarters FTE data will be available at the same time as the existing QNHS data in order to facilitate interpretation of the data on persons employed.

The FTE employment measure for a respondent is the total actual hours worked by the respondent, divided by the average number of hours worked by respondents working in similar (gender, industry sector and employment status) full-time jobs. While changes in the number of persons employed will typically be the primary driver of changes in FTE employment, it will also be affected by other factors. These include increases or decreases in the proportion of total employment accounted for by part-time employment, the number of hours worked by people in employment and other changes.

Summary of main findings

- ◆ In the second quarter of 2013, FTE employment in main jobs was estimated to be 1,645,600, while FTE employment in second jobs was estimated to be 16,500, resulting in total FTE employment of 1,662,100 in the period.
- ◆ From Q2 2008 to Q2 2013, FTE employment in main jobs was down 299,100 (-15.4%) while total FTE employment in main and second jobs was down 303,100 (-15.4%). The number of persons in employment was down 277,400 (-12.9%) over the same period.
- ◆ FTE employment in main jobs increased by 26,800 (+1.7%) over the year to the second quarter of 2013, while FTE employment in second jobs increased by 3,000 (+22.2%) over the same period. Total FTE employment across main and second jobs increased by 29,900 (+1.8%) over the year.
- ◆ Male FTE employment in main jobs in Q2 2013 was estimated to be 933,000 while total male FTE employment was 944,500. Female FTE employment in main jobs was estimated to be 712,700 while total female FTE employment was 717,600 in the same period.

After each Census of Population the sample of households for the QNHS is updated to ensure the sample remains representative. The new sample based on the 2011 Census of Population is being introduced incrementally from Q4 2012 to Q4 2013. This change in sample can lead to some level of variability in estimates, particularly at more detailed levels and some caution is warranted in the interpretation of trends over the period of its introduction.

Concepts and Definitions	For the purpose of this release the same classification, concepts and methods are applied as used for the main QNHS outputs. Reference Period	The release refers to the second quarters (April-June) of the years 2007 to 2013 from the Quarterly National Household Survey (QNHS).
Derivation of Full-Time Equivalent Employment	The Full-Time Equivalent (FTE) employment measure for a respondent is the total actual hours worked by the respondent, divided by the average number of hours worked by respondents working in similar (gender, industry sector and employment status) full-time jobs. While changes in the number of persons employed will typically be the primary driver of changes in FTE employment, it will also be affected by other factors. These include increases or decreases in the proportion of total employment accounted for by part-time employment, the number of hours worked by people in employment and other changes.
Main and Second Job	If a respondent has more than one job, then it is the respondent who self-classifies which job is considered to be the main job. In cases of uncertainty, the respondent is prompted that the main job should be the one in which most hours are usually worked.
Reliability of Estimates Presented	Estimates for number of persons where there are less than 30 persons in a cell are too small to be considered reliable. These estimates are presented with an asterisk (*) in the relevant tables. Where there are 30-49 persons in a cell, estimates are considered to have a wider margin of error and should be treated with caution. These cells are presented with parentheses [].
