Consumer Price Index

December 1999











Food

Food prices rose by 0.3% in the month of December, bringing the annual percentage change in the year to 2.9%. Price increases were recorded for mutton/lamb, fresh vegetables, fresh fruit and breakfast cereals while the price of potatoes and poultry declined.

Drink

Alcoholic drink prices rose marginally by 0.2% in the month. The annual percentage increase in alchohol prices was 3.8%, contributing 0.5% to the overall annual consumer price index in the twelve months to December.

Tobacco


Cigarettes and related tobacco product prices rose sharply in December following the increase in excise duty in the budget. This brought the annual increase to 17.7% in the 12 months to December. The increase in cigarettes contributed approximately 70% to the overall monthly increase in the CPI in December.

Clothing & Footwear

Clothing and Footwear prices dropped marginally this month as a result of some pre Christmas sales. These sales were mainly in ladies wear.

Fuel & Light

Fuel and light prices increased by 1.8% in December to bring the annual percentage change to 7.3%, up from 4.9% in November. Higher crude oil prices has resulted in a number of large increases in the price of home heating oil over the last few months. In December oil prices increased by 12.0%, bringing the annual increase to 44% in December 1999.











Housing

The cost of housing increased in December by 2.3%. This was due to an increase in mortgage interest rates and a rise in local authority rents. The annual change in the 12 months to December is -7.8%, down from -14% in the 12 months to November.

Durable Household Goods

Durable Goods prices rose marginally in December by 0.2%. Prices remained lower in December than the same period last year.

Other Goods

There were marginal increases in the cost of Other Goods, particularly, hair applications, magazines, newspapers and other items.

Transport

Transport costs rose in December by 0.6%. There were higher than average increases in the cost of motor fuel and car repair and maintenance. As a result the annual increase in transport in the year to December is 6.1%, while motor fuel has increased by almost 12% in the year.

Services & Related Expenditure

Services and Related Expenditure showed no major change in December, leaving the annual increase at 5.8%. In the year to December the major price changes were in Education and Training, Other Services, Discos/Nightclubs, Medical Expenses and Hairdressing.

Overall CPI

Consumer Prices grew by 1.1% in December, putting the annual rate of inflation for the twelve months to December at 3.4%. The main factors contributing to the monthly increase were Tobacco, Housing, Transport and Food.
