External Trade

- Exports rose from €83.9bn in 2000 to €86.2bn in 2008. During this period, exports to Great Britain fell from €17.1bn to €14.3bn, while exports to Belgium increased from €4.1bn to €12.2bn.
- Chemicals accounted for just over half of Ireland's exports in 2008. This was driven by a substantial increase in the exports of medical & pharmaceutical products, which rose from €5.3bn in 2000 to €16.7bn in 2008.
- Imports rose slightly between 2000 and 2008, from €55.9bn to €57.0bn. Imports from China have risen, while imports from the USA and Japan have fallen.
- The UK provided 60% of Ireland's fuel imports in 2008.
- Trade in electrical machinery, computers, cars and textiles was lower in 2008 than it was in 2000.

Introduction

This chapter contains information on Ireland's external merchandise trade and shows how it has changed over time.

Long term growth

Between 1971 and 2008, exports at current prices grew from €684m to €86,218m while imports for the same period increased from €958m to €56,964m. The resulting merchandise trade balance at current prices changed from a deficit of €275m in 1971 to a surplus of €29,254m in 2008.

The volume of exports is estimated to have increased by a factor of twenty-four between 1971 and 2008 while import volumes for the same period increased by a factor of eight.

Medium term performance 2000 to 2008

Merchandise imports from the European Union increased from €30,750m in 2000 (EU15) to €36,304m in 2008 (EU27). In 2008 Imports from the EU27 account for 64% of Ireland's total imports.

Imports by main use

The proportion of imports classified as Materials for further Production fell from 61% in 2000 to 56% in 2008, while that of Consumption Goods ready for use increased from 21% to 28% in the same period.

Exports by industrial origin

The share of exports classified as agricultural produce increased from 4.8% in 2000 to 5.8% in 2008, while that of exports classified as industrial produce increased from 92.6% to 92.7%.

Technical Notes

Statistics on Ireland's trade in goods with other countries are compiled and published in detail on a monthly basis. The sources for these estimates are a combination of Customs-based non-EU trade statistics, VAT returns and the Intrastat survey of Irish traders engaged in trade with other EU member states which is conducted by the Revenue Commissioners.

Scope of merchandise trade data

Ireland's merchandise trade is compiled according to the 'general' system of recording international trade whereby imports and exports are recorded at the time the goods cross the territorial boundaries of a country. This differs from the Balance of Payments definition of merchandise trade which records imports and exports only when a transfer of ownership occurs ie when payment is received.

Valuation

For merchandise imports the *cif* value (inclusive of cost, insurance and freight to the point of entry to the State) is used. This is normally the transaction value.

For merchandise exports the *fob* (free on board) value is used. This is the cost of goods to the purchaser abroad up to the point where the goods are put on board the exporting vessel or aircraft or are conveyed to the land frontier.

Exclusions

Certain classes of goods are excluded from the trade statistics. These include, in particular, transit trade, certain categories of temporary trade where the goods are returned to the original country without change of ownership and certain goods which are not the subject of a commercial transaction.

Notes to the tables

In all tables:

- 'Unclassified estimates': estimates which cannot be allocated on a country or commodity basis.
- 'nes': not elsewhere specified or included
- China includes Hong Kong and Macau.

Tables 14.4 and 14.5 show:

- Imports and exports classified according to the United Nations' Standard Trade Classification, Revision 4 (SITC Rev 4) at 1-digit (Section) and 2-digit (Division) levels.

Tables 14.12 and 14.13 show trade classified by trading areas. The countries comprising each of these as of 2008 are as follows:

- EFTA (European Free Trade Area): Iceland, Switzerland, Liechtenstein and Norway.

South Korea, Japan, Taiwan, Hong Kong, Australia, New Zealand, Chile (from 1998), Papua New Guinea (from 1998), Vietnam (from 1998), Peru (from 1998).

- OECD (Organisation for Economic Co-operation and Development): EU (excluding Bulgaria, Cyprus, Estonia, Latvia, Malta, Romania, Slovenia), EFTA (excluding Liechtenstein), Turkey, USA, Canada, Japan, Australia, New Zealand, Mexico (from 1995), South Korea (from 1998); unclassified estimates are excluded.






