Explanatory Notes

Retail sales for entire business

Total monthly retail turnover figures are required for the entire business including all branches.

Include

- Only retail turnover (i.e. sales to private persons or households)
- Total cash value (including VAT) of goods sold during the period under HP and other credit arrangements as well as charges for credit provided by the business itself.

Exclude

- Wholesale turnover (i.e. sales to business concerns, professional, technical and trade buyers)
- Instalment repayments for credit sales in earlier periods

Lottery Call Cards etc.

- Include only the commission received for the sale of lottery tickets or bus tickets or telephone call card sales. Do not include the value of the tickets or cards
