

Labour input on farms down 4.2%

There was a decrease of 8,500 (-4.2%) in the number of annual work units (AWU) worked on farms from 200,200 in 1998 to 191,700 in 1999. The average labour input per farm dropped from 1.4 AWU in 1998 to 1.3 AWU in 1999. *See Table 4 and graph*.

There was a decline of 2,400 (-1.6%) in the number of farms from 146,300 in 1998 to 143,900 in 1999. The average farm size also fell from 29.5 hectares (ha) to 29.3 ha. *See Table 1*.

A comparison of the 1998 and 1999 results shows that :

- ♦ The number of holders fell from 146,200 in 1998 to 143,700 in 1999. The decrease in persons aged under 35 years accounted for most of this decline. *See Table 2*.
- There was a decrease in the number of regular workers (family and non-family) working one annual work unit from 134,700 in 1998 to 127,000 in 1999. See Table 3.

Background Notes

Coverage The estimates cover all farmwork undertaken on the farm. This includes time spent on the organisation and management of the farm but excludes housework.

Persons are included if they are aged 15 years and over and did some farmwork in the year ended 31 May.

The holder is generally the owner of the farm. The spouse of the holder is included if he/she did any farmwork on the holding during the year. Other members of the holder's family include children, uncles and cousins.

Regular non-family workers who were permanently employed on the farm during any part of the year are included.

Annual The amount of time spent working on the holding is estimated by multiplying the number of weeks worked in the year by the average number of hours worked each week. Holidays and sick leave are excluded.

One annual work unit (AWU) is defined as 1,800 hours or more per annum (see Commission Decision 89/651/EEC).

Time worked by casual, contract and relief workers was estimated in terms of person-days. This labour was converted to annual work units on the basis of 1 person-day being equivalent to 8 hours.

The number of farms in the State is estimated by applying grossing factors to each active farm returned in the June sample survey.
