
Decrease in days lost in third quarter

There were 10 industrial disputes, involving 816 workers, in the third quarter of 1999. The number of days lost, 8,864, was down on the second quarter when 26,158 days were lost and was also below the corresponding quarter of 1998, when 13,112 days were lost.

Almost two thirds of the days lost in the third quarter were in the chemicals and chemical products industrial sector. The other sectors affected were: services; agriculture, forestry and fishing; electricity; and transport. *See Table 1.*

In the first nine months of 1999 there were 37,055 days lost, compared to 34,008 for the same period in 1998.

Background Notes

- **Sources** The information on Industrial Disputes is based on details supplied by the Monitoring Unit of the Department of Enterprise, Trade and Employment and on information collected directly from other sources by the Central Statistics Office.
 - **Scope** Disputes are included in this release if they involve a stoppage of work lasting for at least one day and the total time lost is 10 or more person–days.
- **Days Lost** In calculating days lost, it is assumed that work would have continued if no dispute had occurred. No allowance is made for loss of work from unemployment or other causes (such as bad weather) which might have happened even if there was no dispute. The number of days lost is calculated by multiplying the number of persons involved by the number of normal working days during which they were involved in the dispute. Persons working for approximately 40 hours per week are assumed to be working the equivalent of a 5 day week even if the work is spread over more than 5 days.
- **Disputes in Progress** The tables show data on disputes which began and disputes which were in progress in each quarter. The quarterly figures for the number of disputes in progress and for the number of firms and workers involved will not always add to the annual total, since an industrial dispute can be in progress in more than one quarter.
