### Highest number of days lost since 1990

During 1999, an estimated 215,587 days were lost due to industrial disputes. This is the highest figure since 1990 when there were 222,916 days lost.

The 32 industrial disputes that occurred in 1999 affected 36,505 workers and 127 firms. About 90% of the workers involved in disputes during the year were in the services sector and the largest dispute was the nurses strike in October.

The effect of the nurses dispute can be seen in the results for the fourth quarter of 1999, when 178,532 days were lost. *See Table 1*.

Other features include:

- ♦ Last year's figure of 215,587 days lost in disputes was much higher than the 1998 total of 37,374 days. However, the results for the 1990s overall show that the number of days lost was considerably less than in previous decades.
- ♦ On average during the 1990s, 115,825 days per year were lost due to industrial disputes. This compares with 317,078 days per year in the 1980s and 583,978 in the 1970s. *See Graph*.

# **Background Notes**

The information on Industrial Disputes is based on details supplied by the Monitoring Unit of the Department of Enterprise, Trade and Employment and on information collected directly from other sources by the Central Statistics Office.

**Scope** Disputes are included in this release if they involve a stoppage of work lasting for at least one day and the total time lost is 10 or more person-days.

Days Lost In calculating days lost, it is assumed that work would have continued if no dispute had occurred. No allowance is made for loss of work from unemployment or other causes (such as bad weather) which might have happened even if there was no dispute. The number of days lost is calculated by multiplying the number of persons involved by the number of normal working days during which they were involved in the dispute. Persons working for approximately 40 hours per week are assumed to be working the equivalent of a 5 day week even if the work is spread over more than 5 days.

**Disputes in Progress** 

The tables show data on disputes which began and disputes which were in progress in each quarter. The quarterly figures for the number of disputes in progress and for the number of firms and workers involved will not always add to the annual total, since an industrial dispute can be in progress in more than one quarter.
