

# Live Register Flow Analysis

April 2000

#### New registrations increase for females

During April there were 20,945 new registrations on the Live Register, while 22,638 people left the Register giving a net decrease of 1,693 in the month. This compares with a monthly decrease of 4,686 in April 1999.

While the total number of new registrations was lower in April than in March, there were different trends for men and women. The number of men joining the Live Register decreased in April from 12,404 to 10,082, but the number of women joining the Live Register increased from 9,924 in March to 10,863 in April. This reflects the later than usual Easter holiday this year which affected employment in the educational sector at the end of April. *See Table 2*.

Other features include:

- ♦ On average, the Live Register fell by 423 persons per week during April. This compares to an average weekly decrease of 1,721 during March. See Table 2.
- ◆ During April the number of female registrants increased by 173 per week. This compares to an average weekly decrease of 785 in March and an average weekly decrease of 446 during April 1999. *See Table 3*.
- ♦ Outflows from the Live Register were also down in April, with 5,660 people per week leaving the Register compared with 6,186 in March.

The Live Register is not designed to measure unemployment. It includes part-time workers (those who work up to three days a week), seasonal and casual workers entitled to Unemployment Assistance or Benefit. Unemployment is measured by the Quarterly National Household Survey and the latest figure, for September-November 1999, is 88,700 persons unemployed.

### **Background Notes**

# Source and scope of the Live Register

The Live Register is compiled from returns made directly to the Central Statistics Office by each local office of the Department of Social, Community and Family Affairs. It comprises persons under 65 years of age in the following classes:

- All claimants for Unemployment Benefit (UB) excluding systematic short-time workers;
- Applicants for Unemployment Assistance (UA) excluding smallholders and selfemployed persons;
- Other registrants including applicants for credited Social Welfare contributions but excluding those directly involved in an industrial dispute.

#### Live Register Flow Analysis

Changes in the level of flows on and off the Live Register in any month reflect conditions in the labour market and aspects of the social insurance system such as transfers to or from Disability Benefit, exhaustion of Unemployment Benefit (UB) entitlement without qualifying for Unemployment Assistance (UA) etc.

#### **New Registrations**

The aggregate of *new registrations* for each Friday in a given month is used in conjunction with the *net change* over the same period to calculate the *outflow* from the register. A *new registration* is defined as anybody on the Live Register on a particular Friday who was not on it on the previous Friday.

## Unemployment Statistics

The Live Register is not designed to measure unemployment. It includes part-time (those who work up to three days a week), seasonal and casual workers entitled to Unemployment Assistance or Unemployment Benefit. Unemployment is measured by the Quarterly National Household Survey (formerly the annual Labour Force Survey).

#### History

The flow analysis of the Live Register has been published monthly as a separate release since January 1989. Similar details were previously included in the Industrial Analysis of the Live Register, which was discontinued.

## Descriptive articles

The compilation basis for the Live Register statistics from May 1992 onwards is described in the September 1992 issue of the *Statistical Bulletin*. The March 1980 issue contained a description of the basis used up to April 1992 while a more comprehensive treatment of Live Register statistics appeared in the "Report of the Inter-Departmental Study Group on Unemployment Statistics" (Stationery Office Dublin, Prl. 7925, April 1979). The results of a special study of the differences between the Labour Force Survey (LFS) Estimates of Unemployment and the Live Register are contained in the December 1996 issue of the *Statistical Bulletin*.
