Standardised unemployment rate at 14.3% in July

The standardised unemployment rate in July 2011 was 14.3%, up slightly from a rate of 14.2% in June. The monthly increase in the standardised unemployment rate was caused by an increase of 1,500 (+0.3%) in the seasonally adjusted number of persons signing on the Live Register. The latest seasonally adjusted unemployment rate from the QNHS was 14.0% in the first quarter of 2011. The average unemployment rate during 2010 was 13.6%. See table 3.

In July 2011 there were 470,284 people signing on the Live Register representing an increase of 3,460 (+0.7%) over the year. This increase is less than that recorded in June 2011 (+5,066 or +1.1%) and far less than the increase of 34,403 (+8.0%) seen in the year to July 2009. In the year to July 2009 the increase had been as high as 194,181 (+81.5%). See table 1a.

Other features include:

- ◆ On a seasonally adjusted basis there were monthly increases of 1,300 females and 300 males on the Live Register in July 2011. Since May 2010 the seasonally adjusted Live Register total has remained within the range of 440,700 and 448,200, indicating that while there have been fluctuations, the overall trend in the Live Register has remained relatively flat over this period. See table 2a.
- ◆ The number of female claimants increased by 6,150 (+3.7%), to 172,514 over the year while the number of male claimants decreased by 2,690 (-0.9%) to 297,770. This compares with increases of 15,280 (+10.1%) and 19,123 (+6.8%) for females and males respectively in the year to July 2010. See table 1a.
- ◆ The number of long term claimants increased by 45,508 in the year to July 2011, bringing to 40.4% the proportion of claimants that have now been on the Live Register for one year or more. In July 2010 long term claimants made up 31.0% of the total Live Register. See table 7.

The Live Register is not designed to measure unemployment. It includes part-time workers (those who work up to three days a week), seasonal and casual workers entitled to Jobseekers Benefit or Allowance. Unemployment is measured by the Quarterly National Household Survey and the latest estimated number of persons unemployed as of the first quarter of 2011 was 295,700.





Live Register duration of continuous registration

In July 59.6% (280,222) of all claimants on the Live Register were short term claimants. The comparable figure for July 2010 was 69.0% (322,270). The annual fall of 42,048 (-13.0%) in the number of short term claimants consisted of a decrease of 35,184 in the number of male short term claimants and a decrease of 6,864 in female short term claimants. *See table 7.*

The number of long term claimants on the Live Register in July 2011 was 190,062. The number of male long term claimants increased by 32,494 (+31.0%) in the year to July 2011, while the comparable increase for females was 13,014 (+32.9%) giving an overall annual increase of 45,508 (+31.5%) in the number of long term claimants. *See table 7 and graph on page 3.*

Live Register schemes analysis

In July there were 118,990 Jobseekers Benefit (JB) claimants on the Live Register, an annual decrease of 30,738 (-20.5%), while Jobseekers Allowance (JA) claimants increased over the same period by 29,107 (+10.0%) to a level of 320,701. As a result JA claimants account for 68.2% of all persons on the Live Register in July 2011 compared with 62.5% a year earlier. *See table 1a.*

In the year to July 2011 the number of persons aged 25 and over on the Live Register increased by 8,718 (+2.3%), while the number of persons aged under 25 fell by 5,258 (-5.6%). There were annual decreases in all claim types for persons aged under 25 with the largest decrease in JB claims (-5,176 or -31.0%). JB claims for persons aged 25 and over fell by 25,562 (-19.2%) but JA claims increased by 29,173 (+13.6%) and 'Other Registrants' increased by 5,107 (+20.4%). *See table 1b and 1c*

There were 54,123 new registrants on the Live Register in July 2011, consisting of 25,721 JB claims, 25,723 JA claims and 2,679 'Other Registrants'. Males accounted for 26,306 (48.6%) and females 27,817 (51.4%) of all new registrants. On average 5,261 male and 5,563 female new registrants joined the Live Register each week of the month. The difference between the number of new registrants on the Live Register and the increase in the total number on the Live Register is accounted for by closed claims and movements between schemes. *See table 4.*

Live Register regional analysis


Annual increases in the Live Register were recorded in seven of the eight NUTS 3 regions, with a slight decrease in the Mid-West region (-0.8%). The largest percentage increase was in the Midland region (+2.8%), followed by the Mid-East and South-East regions at 1.7% and 1.2% respectively. *See table 5.*

The number of females increased in all regions in the year to July 2011 with the largest percentage increase in the Midland region (+7.3%). The number of males on the Live Register decreased in seven regions with the only increase recorded in the Midland region (+0.3%).

Live Register occupational groups¹

Craft and related (23.9%) remained the largest occupational group on the Live Register in July, despite the fact that the number in the group fell over the year by 7,099 (-5.9%) to 112,571. The second largest annual percentage decrease was in the *Managers and administrators* group (-5.5%). In the year to July 2011 four occupational groups showed Live Register increases. The largest percentage increases were in the *Sales* (+6.6%) and the *Personal and protective service* (+6.3%) groups. *See table 6.*

¹ While the 'No Occupation' group is excluded from the analysis its subtotals are included in the relevant calculations presented in the text.



Live Register casual and part-time workers

There were 85,865 casual and part-time workers on the Live Register in July, which represents 18.3% of the total Live Register. This compares with 16.9% one year earlier when there were 79,072 casual and part-time workers on the Live Register. *See table 8.*

In the year to July 2011 the number of casual and part-time workers increased by 6,793 (+8.6%), with the number of males increasing by 4,015 (+9.6%) and the number of females increasing by 2,778 (+7.4%).

Live Register nationality groupings

In July Irish nationals accounted for 83.1% (390,999) of the number of persons on the Live Register. Of the 79,285 non-Irish nationals, the largest constituent group on the Live Register continued to be nationals from the EU15 to EU27 States (41,732), followed by the UK (19,006). *See table 9.*

In the year to July 2011 the number of Irish nationals on the Live Register increased by 3,387 (+0.9%), while the number of non-Irish nationals increased by 73 (+0.1%).

Background Notes

Source and scope of the Live Register The Live Register is compiled from returns made for each local office to the Central Statistics Office by the Department of Social Protection. It comprises persons under 65 years of age in the following classes:

- ◆ All Claimants for Jobseekers Benefit (JB) excluding systematic short-time workers
- ◆ Applicants for Jobseekers Allowance (JA) excluding smallholders/farm assists and other self-employed persons
- ◆ Other registrants including applicants for credited Social Welfare contributions but excluding those directly involved in an industrial dispute.

Reference Period The reference periods for the Live Register results are as follows:
 July 2011 – 25th June to 29th July 2011
 July 2010 – 26th June to 30th July 2010

Unemployment statistics The Live Register is not designed to measure unemployment. It includes part-time (those who work up to three days a week), seasonal and casual workers entitled to Jobseekers Allowance or Jobseekers Benefit. **Unemployment is measured by the Quarterly National Household Survey** (formerly the Annual Labour Force Survey).

Standardised unemployment rates The Standardised Unemployment Rate (SUR) series in Table 3 is based on the estimated number of persons unemployed expressed as a percentage of the total economically active population (i.e. the Labour Force), using internationally comparable definitions of employment and unemployment, as recommended by the International Labour Office.

Official estimates of the number of persons unemployed and the unemployment rate are produced from the Quarterly National Household Survey (QNHS). The QNHS is the only source of information on unemployment and employment which can apply standard International Labour Organisation (ILO) methodology to the estimation of these key indicators. The background notes of the QNHS release contain more information on the ILO criteria. Given the timelag required to produce estimates from the QNHS and the quarterly periodicity, short-term trends in the Live Register are used to estimate more up-to-date monthly unemployment rates.

The seasonally adjusted QNHS estimate of unemployment is used as a benchmark for February (Quarter 1 QNHS), May (Quarter 2 QNHS), August (Quarter 3 QNHS) and November (Quarter 4 QNHS) each year. The latest QNHS benchmark is updated using the trend in the seasonally adjusted Live Register to allow the estimation of the SUR. Once new QNHS data is available it is used to revise the SUR series. The assumption underlying this methodology is that over short periods the change in the seasonally adjusted Live Register will represent accurately the change in unemployment which will be seen from the QNHS. This methodology has been used since the QNHS was first initiated at the end of 1997.

QNHS The Quarterly National Household Survey (QNHS), which began in September 1997, replaced the Labour Force Survey and provides quarterly estimates of the unemployment rate. Up to and including the fourth quarter of 2008 the QNHS operated on a seasonal quarter basis. As of the first quarter 2009 the QNHS is now undertaken on a calendar quarter basis.

The calendar reference quarters for survey results are:
 Q1 - January to March, Q2 - April to June, Q3 - July to September and Q4 - October to December.

Seasonal adjustment Since January 2011 the seasonal adjustment of the Live Register is completed by applying the X-12-ARIMA model, developed by the U.S. Census Bureau. Seasonal adjustment is conducted using the indirect approach, where each individual series is independently adjusted (male under 25 years, female under 25 years, male 25 years and over and female 25 years and over). To preserve consistency between the individual and aggregate series, the series for gender, age group and total Live Register are then created from these four component series.

The X-12 ARIMA method has the X-11 moving averages process at its core, but builds on this by providing options for pre-treating the series using a regARIMA approach for prior adjustment and series extension. In essence this methodology will estimate seasonal factors while taking account of temporary changes, outliers, level shifts and calendar effects (e.g timing of Easter).

For additional information on the use of X-12-ARIMA see detailed note in the January 2011 Live Register release.

Jobseekers Benefit Duration Prior to 19 January 2004 Jobseekers Benefit was payable for **15 months** (390 days).

From 19 January 2004, Jobseeker's Benefit could be paid for a maximum of **15 months** (390 days) to people who had at least 260 paid PRSI contributions. Jobseeker's Benefit could be paid for a maximum of **12 months** (312 days) to people who had less than 260 paid contributions. (Refers to new claims).

Since 15 October 2008, Jobseeker's Benefit can be paid for a maximum of **12 months** (312 days) to people who have at least 260 paid PRSI contributions. Jobseeker's Benefit can be paid for a maximum of **9 months** (234 days) to people who have less than 260 paid contributions. (Refers to new claims).

Live Register Flows Live Register flows data is sourced from information collected by the Department of Social Protection. The aggregate of new registrations for each month is used in conjunction with the net change over the same period to calculate the outflow from the register. A new registration is defined as anybody on the Live Register in a particular month who was not on it the previous month. Inflows and outflows published in this release do not take account of inter-scheme activity within the Live Register. For example, if a claimant exhausts his/her entitlement to JB and opens a new JA claim this is counted as an outflow in JB and an inflow in JA.

Live Register Area Analysis The basis of the area analysis in Live Register statistics is the Department of Social Protection local office of registration. The areas served by Local Employment Offices do not correspond to specific geographic boundaries. Therefore, registrants at a given local office do not necessarily come from a particular region or area which can be precisely delineated e.g. data for the Cork City Local Office of Registration refers to all persons signing on in Cork City but may include persons not resident in Cork City. **The latest available Live Register data by Province, County and Local Office of Registration will be released on the CSO website through the CSO Main Data Dissemination Service, Database Direct one day after the publication of this release.**

NUTS2 and NUTS3 regions The Regional classifications are based on the NUTS (Nomenclature of Territorial Units) classification used by Eurostat. The NUTS3 regions correspond to the eight Regional Authorities established under the Local Government Act, 1991 (Regional Authorities) (Establishment) Order, 1993, which came into operation on 1 January 1994. The NUTS2 regions, which were proposed by Government and agreed by Eurostat in 1999, are groupings of the NUTS3 regions.

Occupations Live Register occupational data is sourced from information collected by the Department of Social Protection on the most recent occupation of claimants when they sign on the Live Register. The classification used is based on the UK Standard Occupational Classification (SOC). “No occupation” is an additional category and includes those who have never worked and those who have no stated occupation.

Age by Duration Analysis Duration of continuous registration on the Live Register was previously compiled on a half-yearly basis (April and October). The Live Register Age by Duration release has now been replaced by a monthly table in this release. The bi-annual release related to the second last Friday of the reference month but the monthly age by duration data since October 2009 corresponds to the end of month Live Register totals. **Detailed tables relating to regional and scheme data will continue to be made available on the CSO website through the CSO Main Data Dissemination Service, Database Direct on a bi-annual basis.**

Casual and part-time workers The casual and part-time workers’ figure is based on data supplied by the Department of Social Protection. People may apply for Jobseekers Benefit or Jobseekers Allowance if they only work for part of a week and be included on the Live Register.

Nationality Data in the nationality grouping table is sourced from information collected by the Department of Social Protection on the nationality of claimants when they first sign on the Live Register.
