

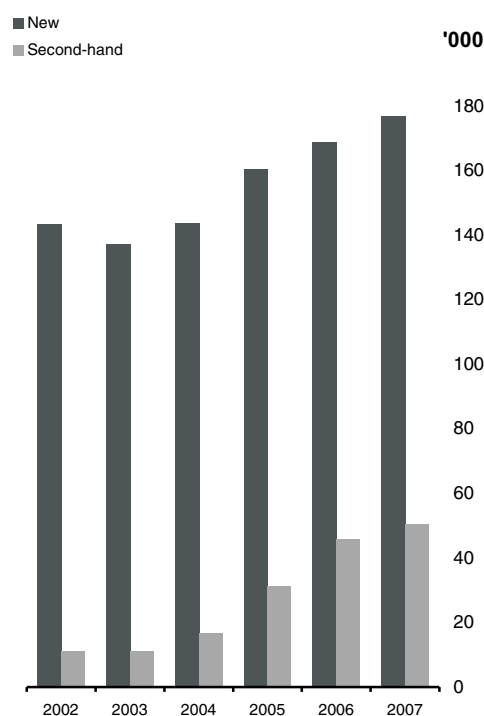

Decrease of 3.2% in new private cars licensed for the first time

There were 5,303 *new private cars* licensed in October, 2007, compared with 5,477 in October, 2006, a decrease of 3.2%. *See Table 1.*

First licensing of *second-hand¹ private cars* increased by 421 (9%) on the same month last year.

The number of *new goods vehicles* licensed in October 2007 was 2,663, compared with 2,909 in the corresponding month last year, a decrease of 8.5%.

The vehicle licensing figures also show that:

- ◆ The total number of all vehicles licensed in October increased by 1% when compared with the same month in 2006.
- ◆ The total number of all *new vehicles* licensed during October was 9,122, compared with 9,442 during the same month in 2006 - a decrease of 3.4%.
- ◆ Of the 9,122 *new vehicles* licensed for the first time in October, there were 38 vehicles fuelled by petrol and electric while petrol and ethanol accounted for 57. *See Table 16.*
- ◆ The highest number of *new private cars* licensed in October, classified by make was Toyota (632) followed by Volkswagen (582), Nissan (552), Ford (551), Opel (411) and Hyundai (210). *See Tables 2 and 9.*

The licensing figures refer to vehicles taxed for road use only and are classified by taxation class.

¹ The term 'second-hand' refers to imported used vehicles. (See definitions at back of release).

Background Notes

Source The vehicle licensing figures are compiled from data supplied by the Department of the Environment, Heritage and Local Government, Vehicle Registration Unit. These data provide details on the number of private cars, goods vehicles, motor cycles, and other vehicles licensed for the first time in each city and county council, classified by make and size, during a given month.

History The release titled 'Vehicles Licensed for the First Time' commenced in January 1993. It replaced the series previously published as 'Particulars of Vehicles Registered and Licensed for the First Time'.

In January 1993, separate systems for vehicle registration and licensing were introduced. The Office of the Revenue Commissioners became responsible for the compilation of vehicle registrations while the Department of the Environment, Heritage and Local Government retained responsibility for vehicle licensing.

The licensing process where applicable follows the registration process. Registration and licensing figures may differ in a given month for a number of reasons, some of which are outlined below:

- Vehicles which under the previous system would have been licensed in the latter part of a particular month may not now be licensed until a later month because of the time lapse between registration and first licensing.
- Vehicles which are not used in a public place (e.g. tractors for use exclusively on the land) are registered but may not need to be licensed.

From 31st of October 1999, detailed information on agricultural vehicles is no longer published in accordance with Commission Decision 92/157/EEC as upheld on 28th May 1998.

Definitions **Second-hand:** The term 'second-hand vehicles' in this release, refers to imported used vehicles which are licensed for use in a public place, in this country, for the first time.

Exempt: The term 'exempt vehicles' in this release, refers to vehicles which are licensed for the first time but are exempt from liability to pay road tax. Exempt vehicles can be divided into four main categories:

- State owned
- Diplomatic
- Fire services
- Disabled drivers

Machines or Contrivances: Vehicles included under this category are mobile machines, forklifts, excavators and diggers.
